



## **Internal Training on Child Inclusive Mediation A Practical Focus**

This 5-day 40-hour intensive course provides skills for family mediators working with families entrenched in conflict. The course will provide a strong practical focus on the subtle and delicate skills required to bring about a series of transformative shifts in parents, helping them to gain a broader perspective on why they are in conflict, what effect this has had on their children and how they might manage their parental alliance in the future.

### **The course will assist practitioners to develop skills including –**

- To gain an accessible and applicable working knowledge of attachment theory, neurobiology and evolutionary theory
- How to interview a child and to look for indications of how their parents' conflict has impacted on them.
- To formulate these impressions into a narrative to feedback to the parents that will be persuasive and motivating
- 'Externalising skills' whereby the parents are helped to become more generous and forgiving towards each other.
- The skill of facilitating parents to actively and willingly contribute to how they will positively conduct their alliance in the future.
- To gain practical knowledge on how to provide Child Inclusive Mediation services in Hong Kong.

### **Trainer: Bill Hewlett**

Bill is the former Clinical Services Specialist in Family Dispute Resolution with Relationships Australia, and a lead trainer for the Australian Institute for relationship Studies, responsible for the clinical practice of six mediation centers.

Bill has developed an innovative and effective training model of practice, which responds to the current challenges of the family law system, specialising in working with highly conflicted clients.
